Statistical Yearbook of Podkarpackie Voivodship 2006 is the essential comprehensive publication of the Office intended for a wide range of readers. It contains a large extent of statistical data describing phenomena and processes occurring in the voivodship, characterizing living standard of the society in Podkarpacie as well as the economic situation. Selected data on the Podkarpackie Voivodship are presented compared to the country and other voivodship.



Podkarpackie Voivodship 2006. Subregions, powiats, gminas. The publication is a supplement to "The Statistical Yearbook of Podkarpackie Voivodship" within the scope of presentation of data in the spatial breakdown. The scope of presented information covers among other things environmental protection, demographic situation, labour market, education, health care, culture and tourism, agriculture and forestry, public finance, investment and entities of the national economy.

Entities of the national economy registered in the National Official Register of Economic Units REGON. Podkarpackie Voivodship against the background of the regions of the European Union. The publication consists of five chapters. The first one discusses aims and principles of the European regional policy and introduces the Structural Funds briefly. The second chapter concerns the territorial division of the Union and the NUTS classification. In the third one social and economic development measure methods were described whereas a comparison between the Union regions considering area size, population, the social and economic development level was made in the fourth chapter. The fifth chapter includes conclusions and summary. The last part of the publication contains tables with data for particular countries and regions of the Union.
