Register (REGON) is continuously updated collection of information on the entities of the national economy in a computer system in the form of the central database and the field databases . It was established on the basis of Article 41 paragraph 1 Point 1 of Act of 29 June 1995 on publics statistics (OI U. of 2012, item 591, as amended)

Entries in a register REGON shall be done by the following:

- legal persons,
- organizational units without legal personality,
- natural persons conducting economic activity (including those running individual farms),
- local units of above mentioned entities.

Each entity is given a unique identification number REGON. In accordance with Article 42 paragraph 6 of the Act on public statistics an entity is obliged to submit a relevant application within 14 days from the occurrence of the circumstances justifying the entry, change or deletion from the register (REGON).

Applications for entry, change or liquidation of entities of the national economy in the register (REGON) are accepted at the headquarters of the Statistical Office in Rzeszów in room 2, ground floor, telephone 17 853 52 10, 17 853 52 10 ext. 151, 153.
